
# Low & Zero Carbon framework

# Benefits for social housing landlords

This framework has been developed to support social landlords and other public sector bodies to help them achieve their net-zero carbon targets across the UK. The framework provides both materials and accredited installers to retrofit the major technologies that landlords are using to reduce their carbon footprint.

Dedicated materials lots cover domestic and commercial air-source and ground-source heat pumps, photovoltaic (PV) panels, batteries and heat interface units (HIUs). Accredited installation lots have national ground-source heat pump (GSHP) lots and regional PV and air-source heat pump (ASHP) lots.

The framework is a one-stop procurement service that provides cost savings by using collaborative purchasing strategies and specialist local supply chains. We actively support you using this framework and provide ongoing support throughout the term of the contract, including ongoing price management to ensure true long term best value is preserved beyond the initial contract award. The varying forms of the JCT, or any standard form for maintenance or construction contracts, are available under the framework offered as tailored solutions to meet any project requirements.


# Regional lots to support SMEs
